

MEPRD will accept closeout documentation for grant payout prior to the Illinois Department of Transportation's (IDOT's) final project closeout under the following limited circumstances:

- The project funded in-part by MEPRD is also funded by an IDOT grant; and
- The project is complete and open to the public; and
- The project's latest IDOT pay estimate shows at least 95% completion.

If a project meets all the above conditions, the Project Sponsor can begin the process of requesting conditional closeout by assembling and submitting the following items to MEPRD:

- 1. **Conditional Closeout Request Form.** Fill-out the Conditional Closeout Request Form on pages 2-3 and sign the "Certification Statement and Acknowledgement of Obligations." (*Signee must be Mayor, Board President, or Chief Executive of organization or department*).
- 2. **Park and Trail Grant Reimbursement Form and Supporting Documentation.** The project sponsor must submit a complete grant reimbursement packet. Supporting documents must be sufficiently detailed such that all documented costs may be verified by a third-party audit.
- 3. **Grant/LPA Agreement.** Submit a copy of the agreement between the Project Sponsor and IDOT, including any amendments thereto.
- 4. Listing of Known Deficiencies. Provide a complete listing of all known supporting documents or records that cannot be furnished at this time due to pending closeout actions by IDOT.

Conditional Grant Reimbursement: If a conditional closeout is granted, MEPRD will process the reimbursement request and, if approved, issue payment based on <u>actual and final projects costs for eligible</u> <u>items</u> as detailed in the Project Sponsor's supporting documents and accounting records. Future estimates or unsubstantiated project costs will not be factored into the reimbursement amount.

Final Acceptance, Closeout, and Settlement: After the conclusion of IDOT's project closeout process, the Project Sponsor must submit within ninety (90) days of such date the following:

- 1. A newly completed Grant Reimbursement Form, including documentation of final project revenue and expenses; and
- 2. Documentation in support of the final closeout by IDOT; and
- 3. Copies of all supporting documents that were identified as 'deficient' in the initial conditional closeout request.

Failure to submit the final acceptance and closeout process within ninety days of IDOT's closeout may jeopardize the Project Sponsor's ability to apply for funding in future MEPRD grant cycles but shall not annul the Project Sponsor's obligation to submit the final acceptance and closeout information to MEPRD.

If, upon MEPRD's review of these documents, it is found that the Project Sponsor is eligible for a grant reimbursement amount *greater than* what was already remitted, MEPRD will issue an additional payment for the difference, not to exceed the original grant amount awarded by MEPRD.

If the Project Sponsor received a MEPRD payout that *exceeds* the maximum eligible reimbursement amount, the Project Sponsor will be required to refund MEPRD for the excess portion. MEPRD, nor the Project Sponsor, will pay interest on any amounts owed to the other.
