Executive Director Buehlhorn gave a brief update on the status of the OSLAD grants for Malcolm Martin Memorial Park. After review of the attorney's decision, OSLAD 1 will be defined as Change Order #5 and OSLAD 2 will be Change Order #6. A letter requesting an extension for OSLAD will be sent to IDNR due to logistics problems on the site with the Mississippi River Overlook.

The Executive Director also gave a brief report on the McKinley Bridge Ramp Down Project and Halverson Construction had not yet responded to the final outline. Engineer Bill Baudendistel explained that we have moved the alignment towards the east and revisions were almost completed.

Executive Director Buehlhorn and Engineer Bill Baudendistel explained the potential liner problems at the Gateway Geyser and that the Geyser would be closed after the weekend of September 16 to initiate necessary repairs. They will be meeting with a leak detection team later

in the week to assess the situation. The insurance company and Gateway Center of Metropolitan St. Louis have been advised.
